
With respect to the above subject, Circular referred in (3) [REDACTED] above is herewith enclosed, vide which attention was drawn towards the launching of Public Portal for Gazetted Entitlement (<http://agopublic.kar.nic.in/gepublic>) which enabled the State Gazetted Officers serviced by Accountant General's Office to only **view** their payslips / leave details online.

Vide AG's letter referred in (2) (letter enclosed) above it is stated that the details available on the Public Portal are digitally signed by the authorized officers before sending the data to the portal and hence now onwards the officers can **download** the payslips / leave details and present it for payment.

It is also informed that the physical payslips will be issued to officers only upto 31st December 2019 and from January 2020 onwards the officers are requested to download the payslips / leave details from the Public Portal and present the same to HRMS for the processing.

The Public Portal which works on real time basis would enhance the performance and satisfy the Users in a speedy way.

It is herewith again requested to give instructions to all departments / boards / corporations under your authority to carry-out necessary action for the registration to enable optimum use of the portal by the DDOs and the Users.

With respect to the above subject, AG(A&E)'s D.O. Letter referred above is herewith enclosed, vide which attention is drawn towards the launching of Public Portal for Gazetted Entitlement (<http://agopublic.kar.nic.in/gepublic>) which enables the State Gazetted Officers serviced by Accountant General's Office to view their payslips / leave details online. The portal is launched at NIC Data Centre, Bengaluru with support of NIC Bengaluru and HRMS of the State.

Currently the details available on the portal are only for view and not for payment purpose as the information is not digitally signed. However, A.G.'s Office is in the process of adding digital signatures of the authorized officers while approving the claims before sending the data to the portal and when this process is completed, the Officers can download the payslips/leave details.

The Public Portal which works on real time basis would enhance the performance and satisfy the Users in a speedy way.

A copy of the Help Document and a list of e-mail Addresses are appended herewith to process the registration of the officers including the DDO's in the Portal as an initial mandatory registry. It is herewith requested to give instructions to all departments/boards/corporations under your authority to carry-out necessary action for the registration to enable optimum use of the portal by the DDOs and the Users.

The physical pay slips will also be issued to the officers up to 31-December-2019 and from January-2020, the Officers may be requested to download the payslips/ leave details from the public portal and present the same to HRMS for further processing. You are requested to instruct the Directorate of HRMS, Bengaluru to make necessary arrangements to receive the digitally signed documents sent by this office from time to time.
