Sub: Dearness Allowance to Pensioners/Family Pensioners – revision of rates.

Read: G.O.No.FD(Spl) 24 PET 99, dated :6.10.1999.

ORDER NO. FD(SPL) 9 PET 2000, BANGALORE, DATED : 19.5.2000

Government are pleased to sanction increase in the rates of Dearness Allowance from existing 37% to 38% of basic pension/family pension to the State Government Pensioners/Family Pensioners and the pensioners and family pensioners of the Aided Educational Institutions whose pension/family pension is paid out of the Consolidated Fund of the State, with effect from 1st January 2000.

2. Basic pension/Family pension shall include Dearness Allowance sanctioned up to 1.1.1996 vide G.O.No: FD(Spl) 35 PET 96 dated: 8.5.1996 in respect of the following categories of pensioners:

(a) Employees who were on AICTE/UGC/ICAR scales of Pay (other than teachers of Medical and Dental Colleges) and who retired on or after 1.1.1996.

(b) Judicial Officers who have retired prior to 1.7.1996.

3. The payment on account of the increase in Dearness Allowance as per these orders involving fractions of 50 paise and above shall be rounded off to the next rupee and fractions less than 50 paise shall be ignored.
