PREAMBLE :

In Government Official Memorandum and Orders at (1) & (2) read above, the Procedure for release of grants to Zilla Panchayats/Taluk Panchayats/Grama Panchayaths has been issued. Accordingly for the year 2013-14, 2nd installment i.e. August 2013 to December 2013 has been released vide Govt. Order cited under (5) read above. Now considered for grant release 3rd and final installment for the months of January 2014 to March 2014. Hence the following order.


GOVT.ORDER NO:FD 3 ZPA2013, BANGALORE, DATED: 18th December 2013

The Government are pleased to release a sum of Rs.316.68 lakh (Rupees Three hundred and Sixteen lakh and Sixty eight thousand only) (on account) grants to Grama Panchayats for the month of January 2014 to March 2014 for the implementation of Plan schemes of Grama Panchayath programmes. The details of the release under each major head pertaining to Grama Panchayaths are shown in the Annexrure.

The schemes implemented by Grama Panchayats are shown under a Distinct Minor head 198-Financial Assistance to Grama Panchayats in the budget. The Chief Account Officers of Zilla Panchayaths shall make Taluk Panchayathwise allocations. The Taluk Panchayths should prefer bills on the Treasury enclosing a Grama Panchayathwise allocations and debit to consolidated fund of the State. The Treasury Officer shall adjust the funds to the credit of GPs based on the allocation statement furnished by Executive Officers of concerned Taluk Panchayths as per new scheme codes shown in the link document.

These grants shall be met out of the budget provision of the year 2013-14 under the Head of Accounts indicated in annexure appended to this order.
