**CORRIGENDUM**


Clause (iii) of Para-1 of the Order portion of Government Order of even number dated 29-8-2008 shall be substituted as follows :-

“(iii) In respect of Secondary School Teachers and PU Lecturers who were appointed prior to 01.08.2008, the Special Allowance of Rs 200/-p.m sanctioned w.e.f. 01.04.2006 in GO No FD 14 SRP 2006, dated 12.05.2006 shall be continued until further orders.”

After the above clause (iii) the following entries shall be inserted as clause (iv):-

“(iv) The Secondary School Teachers and PU Lecturers who are appointed on or after 01.08.2008 are not entitled for Special Allowance of Rs 200/-p.m. in terms of G.O. No FD 14 SRP 2006 dated 12.5.2006”.
